This verbal report was presented by the Chair of the Coromandel Catchment Committee (J Sanford). It was noted that he had been abroad for much of the period to be reported on. He added that the quality of the Zone should be praised and that it was important to ensure that the environment is protected for future generations.

8. <u>Coromandel Zone Status Report</u>

This report was presented by the Zone Manager (D Allen). The report was taken as read. The report updated the Committee on matters related to its terms of reference that had occurred within the zone.

The following matters were raised:

- The success of the Arthur Hinds Scholarship.
- Erosion mitigation and management methods were discussed. It was noted that poplar trees were a cost effective way to manage and slow the rate of erosion along riverbanks. The poplar tree material would be sourced (harvested) from those same sites around the Zone saving transporting materials around the region.
- The role of the Waikato Regional Council and Central Government in the Inter Regional
 Marine Pathways document and planning was discussed. It was noted that the members
 could provide feedback on the draft plan by sending feedback to staff. Staff would collate
 the feedback and respond on their behalf. There were a number of matters that needed
 to be considered such resource allocation and financial matters.
- The spread of Fanworm was discussed. It was noted that marinas do have a policy where boat owners must clean their hulls at least every 12 months. The impact of increased global shipping trade was also noted to be a major contributor of the marine pest.
- The role of the Waikato Regional Council in the biosecurity sector was explained and discussed.
- The need for increased education on biosecurity matters was emphasised.
 It was noted that sediment monitoring was ongoing. Sediment plates were being installed in four harbours which will in the long term provide better data. The criteria of the water quality monitoring programme locations was discussed. It was noted that it was a science based decision and one influenced by cost. The Zone Manager undertook to provide W Brooks the locations of the Tairua sites.
- The impacts of waste water plants and other infrastructure was discussed. It was noted that there was a need to ensure that all waste water systems work effectively and within the consent conditions that apply to them.
- The impact that mangroves have on catchments was discussed. It was noted that there was need to develop a balanced approach to the management of mangroves, which included the role they play in the eco-system and as a buffer between land and sea.
- It was noted that there was a need to consider the impact that climate change was having on the environment, pest spread, and environment impacts. It must be taken seriously to plan effectively in the future.
- It was clarified that there had not been a Statement of Intent meeting for a while at the direction of TCDC while the local mangroves bill progressed. Staff noted WRC's ongoing commitment to the SOI and its Regional Plan review (of which Mangroves will be in the first tranche of topics).

This report was presented by the Senior Policy Advisor (B Bunting). The presentation explained to the Committee the range of reports and plans that the Waikato Regional Council produced and was involved in, in the context of the wider machinery of government.

The following matters were raised:

- It was noted that Harbour Catchment Plans are non-statutory strategic region specific plans. The role and contents of policy and implementation was discussed.
- Environment management plans that result from treaty settlements were discussed. It
 was noted that there are some challenges in relation to the way that treaty settlements
 were implemented. Matters such as the role of co-governance and the impacts that it
 may have on the vision, strategy, and management of the current catchment plans were
 highlighted.

This report was presented by the Senior Policy Advisor (B Bunting). The presentation updated the Committee on aspects of the Sea Change Plan and the role that the Waikato Regional Council in relation to it.

The following matters were raised:

- The Office of the Auditor General's report on the Plan was discussed. It was noted that it had highlighted some gaps in consultation with the communities that it affected.
- The selection process of the panel that worked on the Plan was described and discussed.
- It was noted that there is a need to include economic development in the plans to continue to develop local and regional economies.
- It was noted that the Waikato Regional Council perform a number of activities that the Plan states.
- It was noted that there was a need for more consideration in relation to the resources and rates that were allocated to deliver aspects of the Plan.
- The potential cost allocations as a result of the implementation of the Plan were discussed. It was noted that there was a need to look at the aspects of the Plan and look at what investment is needed and where.
- The proposed changes to the Plan was discussed. It was noted that there was some inconsistency with legislation and the matter was being worked through and would develop as more clarification on issues are resolved.

12. Flood Campaign Update

The report was presented by the Senior Advisor, Projects (J Beaufill). It was taken as read. The report explained aspects of the Flood Campaign that would be implemented by the Waikato Regional Council.

The following matters were discussed:

- It was noted that the schemes in Zone were strategically important in the wider flood protection network.
- The method of communications and publicity for the plan was discussed. It was noted
 that an inclusive approach was needed to get maximum effect and achieve positive
 outcomes.
- The work of the flood protection work that occurred in the Zone was discussed. It was noted that there could be a benefit of explaining to ratepayers what benefits were generated.
- It was noted that the natural hazards portfolio includes all sectors of the economy, communities, and levels of government. It was emphasised that there was a fully cooperative approach.
- The lessons learned from the 2004 weather bomb was discussed. It was noted the
 investment in the scheme was built on the memories of that devastating event. People
 needed to know the history of events that have occurred over time to move forward
 effectively.

14. <u>Integrated Catchment Management Committee Updates: Update on Hill Country Erosion</u> <u>Fund and One Billion Tree Funding</u>

This report was presented by the Zone Manager (D Allen). It was taken as read. The report provided the Committee with an update on the last meeting of the Integrated Catchment Management Committee.

The following matters were raised:

- Plantation forests located on steep hillsides was discussed. It was noted that it was not
 covered in the hill country erosion fund. The retirement of land over 45 degrees may go
 back to native forest. The matter would be discussed in more detail at the next meeting.
- It was noted that Central Government would now fund more interventions to try and mitigate the impacts of Kauri Dieback in New Zealand.
- The impacts that treaty settlements had on the local government sector was discussed. It
 was noted that discussions are ongoing to provide better clarity on the cost and role of
 local government in final settlements.
- A range of other central government activities being undertaken in part by council was discussed (Auckland Fruit Fly, Kauri Dieback, Treaty settlements, Fish Friendly)..
- It was noted that there would need to be the development of a durable and quality source of plants for use on retired land.

15. Fonterra 50 Catchments Project

This report was presented by the Programme Manager from Fonterra (H Urry). The presentation provided the Committee with an update on the Fonterra 50 catchments Project that the co-operative had begun to implement around New Zealand.

Cr S husband left the meeting at 1.11pm.

The following matters were raised:

- It was noted that Fonterra was proactive in the development and implementation of Environment Farm Plans with its members.
- It was noted that Fonterra would work with farmers and other stakeholders, to develop shared goals and outcomes that were in-line with the framework that had been outlined in the Healthy Rivers Plan.
- The role of Fonterra in the context of environmental enforcement was discussed. It was noted that there was no a direct role in that matter, but through other quality measurement standards they can enforce.
- The implementation of the project at community level was discussed.

16. Zone Committee Biodiversity

This report was presented by the Senior Biodiversity Officer (A Julian). The report provided the Committee with a profile on biodiversity of the Zone and the wider Waikato region.

The following matters were raised:

 The role of the Council in the protection and enhancement of biodiversity throughout the Waikato region was explained and discussed, along with the challenges and constraints that the Council faced in order to meet its statutory and regional commitments.

- Aspects of the Willis Report was discussed in relation to Local Government and the Resource Management Act.
- It was noted that the Zone had a number of natural sites of significance such as the Firth of Thames, the Peat Dome, and remnants of Kahikatea.
- It was noted that Waikato Regional Council took a balanced approach to biodiversity and must consider a range of factors such as resourcing levels, funding sources, and other policy or political factors that have an impact on an issue.

J Davis left the meeting at 2.05pm.

- Aspects of the way in which catchments and mangroves work together to conserve and promote biodiversity in salt water catchments was discussed. It was noted that mangroves had a role in the wider benefits and role in the protection of the community.
- The new staff member, K Richardson, from the Biodiversity Team was introduced.

17. Member Reports and Upcoming Agenda Items

Members' reports

Members of the Committee were provided with an opportunity to discuss matters relevant to the Committee.

The following reports were provided:

- P Wood highlighted the role of wilding pines and the impact that it had on the environment.
- J Morrison noted that the planned cycleway from Pauanui to Tairua was now under construction, which included Hikuai. It was noted that all three communities were distinct and would be impacted in different ways. She also noted that the construction locations along the river bank and the neighbouring wetland contained a number of birds and other creatures, which would be harmed by the removal of some of the wetland. Other aspects of the resource consent process were also discussed.
- M Donoghue expressed concern over state of the environment, the need for courage to
 deal with the major issues, and the need for all people and government to be proactive
 in the protection of the environment. He also discussed the impact of sediment runoff
 due to forestry harvesting and management practices.

- W Brooks expressed concern at a lot of drainage and construction waste that had been left at the metal dump at Tairua. It was noted that this could have a negative impact on the area around it. Staff undertook to find out which council it belonged to and would report back in due course. He also emphasised the importance of greater transparency in relation to compliance enforcement matters.
- W Brljevich noted that there was heavy rain in the Whangapoua catchment. She expressed concern that there could be slash and that she wanted the risk to be mitigated as much as possible. It was also noted that there appeared to be no immediate environmental damage from the boat that ran aground the week prior.
- P Wood and M Donoghue highlighted the need for careful design and placement of floodgates and other infrastructure for all current and future developments in the Zone.
- Cr T Walker put a question to staff at the meeting asking if the Waikato Regional Council
 was actively developing or experimenting with the genetic engineering of pests. The Staff
 stated that it does not. CRISPA genetic engineering methods were discussed in the context
 of pest eradication.
