Subject: Re: Prospective Mayors - We'd like to hear your thoughts

Kia Ora Penne

Thank you for the chance to provide feedback on aspects which have a direct impact on Hahei residents, holiday home owners and visitors. My approach from when announcing my decision to stand as Mayor, has been the reengagement of communities along with the empowerment of community boards. I believe council's long term and annual plans require total revision targeting matters which impact directly on communities of interest - in your case Hahei.

My plan to deal with the matters you raise? I will ask your community what are your priorities - being pragmatic, I believe you will come back in this order: Point 3 including Point 2; Point 1; Point 6; Point 4; Point 5.

Drinking water - in 2022 every resident, where a reticulated supply is available or can be provided, must have acceptable drinking water. I do not support Three Waters, reasons, I cannot see a single entity being able to commit to such a vast area, I do not like the structure as our residents lose control, and we are not being appropriately compensated for the water asset. I believe water services should remain a general charge in your rates.

Reticulated Sewage - this should be the ultimate goal. I want to provide clear plans to communities across all infrastructure aspects - your sewage scheme programme would fit into this. This will then provide communities with a clear indication of works, budgets and timelines.

Climate change is here and it is pleasing to see the work council has undertaken on Shoreline Management. This does need to go further to look at land/water impacts along with emergency response for both people and property. I do not believe that council will have the ability to either protect or insure properties - it does have a duty to advise of potential risk. We do need to continue to mitigate the risk of climate change - again I will be seeking advice on this.

I am an advocate for planned development - we need to ensure that our commercial operators are sustainable and that we can provide the services that all people either living or visiting our communities require. Land zoning and the district plan is another area that requires reviewing - this to include the likes of your village development to potential housing and accommodation options. The key here is planned development.

Just a couple of observations - I have concerns over our community cohesiveness - this incorporates the likes of health services, community and property safety, housing and employment. Some of these are not normally council impacts, however due to major issues here, we need to push the government on these on behalf of our residents and communities. In tandem with these are aspects such as recreation, arts, heritage and culture - all so important in our communities today. I would like to see these included as points that matter for Hahei.
