Thanks for the information during our phone conversation the other day.

I went through the process of working out what I want from the council in your situation and I came up with the following thoughts.

I would expect a township like Hahei to have reticulated sewerage. I am aware of the problems created by having too many sewerage tanks in a settled area. How to make that happen in a timely and cost effective manner i have no simple answer. In view of my comment about the number of sewerage tanks I would hesitate to agree with further growth until the sewerage has been sorted.

I don't support Three Waters, however I do recognise that this proposal came from some real problems around the country. I can't see how a larger organisation would do a better job. Centralising doesn't always work. I am concerned about the supply of water especially in a busy town like Hahei.

As regards the further development of Hahei. I do not have enough information. I do like how it has developed so far. If I become the Mayor I would expect that all parties should be part of the discussion.

As regards the marine reserve concept I have heard a lot more about this during the other meeting held to date. I understand this is a WRC initiative and it still has to go out for consultation. I have seen the benefits of of marine reserves in other areas.
