General Business

Update Visitor Management:

Ray reported that there has been no recent action from DOC, presumably waiting until after the election. No sign of the track from the beach being finished (DOC has stated will be open for Xmas). There is still no deal between DOC and Ian Carter re his car park. It was noted that it has been good to have the bus operating all year to the car park at the top of Grange Road.

Spatial Planning:

Note that we should be referring to land designations, not council rezoning. Tracks on the 94 Hahei Beach Road subdivision have been cut. It would be good to get a wider consensus for where tracks should be established. There needs to be land owners sign off in principle before any survey of the community on future walking / cycle tracks etc. Discussion needs to be had with landowners.

Hahei Ambassadors Season Two

David has been talking to local businesses to help us to help them and noted he has had a good response so far. Some businesses have indicated that they want to show thanks to ambassadors by providing them with a thank you by way of such things as coffees etc. So far David has 3 new ambassadors with the balance so far confirmed as coming from last year's group of 27. Paper with update and planning presented to the meeting. David expressed a vote of thanks to Penne for the poster she created and the mast head for correspondence. It was suggested a target of 40 volunteers was realistic. It was noted that there is an issue with visitors not noticing the signs for where to get the bus to CC.
